Preventive skin protection by use of skin-protecting agents is recommended. To avoid skin problems reduce the wearing of gloves to the required minimum.

Material of gloves:

The selection of the suitable gloves does not only depend on the material, but also on further marks of quality and varies from manufacturer to manufacturer. As the product is a preparation of several substances, the resistance of the glove material can not be calculated in advance and has therefore to be checked prior to the application.


